This summary of the School Accountability Report Card (SARC) is intended to provide parents and community members with a quick snapshot of school accountability. The data presented in this report are reported for the 2007-08 school year, except the School Finances and School Completion data that are reported for the 2006-07 school year. About This School

Oasis High School began as the Oasis Independent Study Program of the Fallbrook (CA) Union High School District in 1994; it became Oasis High School, the third high school in the District in 1995, for the purpose of providing a second alternative learning setting and modality complementing the traditional Fallbrook High School. The three high schools in the Fallbrook Union High School District, which serve grades 9-12, have a total enrollment of approximately 2,900 students.

In January 2008 Oasis High School completed its planned move to the South Stagecoach Lane site it now shares with the FUHSD office complex. The operating costs of Oasis High School are covered by ADA (Average Daily Attendance) and several categorical funds.

Oasis High School is an alternative high school providing the voluntary option of independent study to qualified students from both the Fallbrook Union High School District and adjoining districts. Each student must have the option of returning to seat-time instruction in a regular classroom, so no suspended or expelled students are eligible for Oasis, unless they are given a classroom option. The Oasis High School staff is proud of the exceptional academic progress, personal growth, and social success its graduates have experienced. Teachers, parents/guardians, and students share a focused vision of what is required to achieve academic progress, personal growth, and social success for all students. As a unique option in a newly renovated location, Oasis projects a calm, supportive ambience, a 95% graduation rate, and an energetic, curious, industrious, and well-rounded student body; student life is further enriched by outside speakers, annual field-trips, and additional student services provided by the District's vocational career specialist, impact counselor, drug & alcohol coordinator, and the special education psychologist. Oasis students come from Fallbrook, Bonsall, Rainbow, De Luz, and Camp Pendleton as well as from neighboring school districts via inter-district transfer.

The district has adopted the A Service cleaning standard and schedule. Teaching staff members provide supervision, and when needs arise, Fallbrook Union High school campus Supervisors are dispatched by radio communication. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. For the 2007-2008 school year, the district's governing board has approved a deferred maintenance budget of \$130,000, which represents 0.47% of the district's general fund budget. In the 2007-2008 school year, Oasis has moved to its own location in the FUHSD office complex. No complaints regarding facilities were filed in the 2007-2008 school year.

In 2007-08, the total operating cost for the Fallbrook Union High School District was \$27,943,505. This amount was derived from funds received from general education, special education and for federal, state, and local special projects. Funds were also received from the California State Lottery. Approximately \$25,141,561 per student was spent for classroom-related activities, such as teachers, instructional aides, books, supplies, and equipment. The balance of the expenditures covered district support services, school administration, district administration, transportation, maintenance, and operations. Special categorical revenue was received for the following programs: 10th Grade Counseling; EIA/LEP, Title V, School Library, School Safety and Violence Prevention, Arts & Music and Title III.

XII. Instructional Planning and Scheduling Professional Development
